THE APPOINTMENT OF THE } (Supersedes General Order No. 13-12)
MERIT SELECTION PANEL }

Pursuant to 28 U.S.C. § 631(b)(5) and the relevant standards and procedures promulgated by the Judicial Conference of the United States, the Court must appoint a Merit Selection Panel to assist the Court with the appointment and reappointment of magistrate judges. The Court's current Merit Selection Panel was appointed on October 21, 2013, by General Order No. 13-12. However, it is now necessary to appoint one new member, a new Chair and Vice Chair, and reappoint Panel members whose terms will expire on December 31, 2014.

IT IS THEREFORE ORDERED that the following individual be, and hereby is, appointed to the Court's Merit Selection Panel for a three-year term beginning July 8, 2014: Michael G. Yoder. Mr. Yoder shall be eligible for reappointment to the Merit Selection Panel for one additional term of three years, at the discretion of the Court.

IT IS FURTHER ORDERED that Helen Zukin shall serve as Chair of the Merit Selection Panel for a term of one year and seven months, beginning June 1, 2014, and that Theresa Traber shall serve as Vice Chair of the Panel for the same term. The Court anticipates that, at the end of this term, either the Chair and Vice Chair will be


1 reappointed to serve an additional term, but not to exceed December 31, 2016.

2 IT IS FURTHER ORDERED that each of the following individuals be, and
3 hereby is, reappointed to the Court's Merit Selection Panel for one three-year term
4 beginning January 1, 2015: Fernando Aenlle-Rocha; Yolanda Barrera; Mark Drooms;
5 Matthew Hodel; John Holcomb; Sandra Munoz; Dianne Baquet Smith; and Michael
6 Tomasulo. None of these individuals shall be eligible for immediate reappointment to
7 the Merit Selection Panel upon the expiration of this term.

8 IT IS FURTHER ORDERED that the Merit Selection Panel whose full
9 membership is set forth in Attachment A to this General Order is hereby appointed to
10 recommend candidates to fill all magistrate judge vacancies that may occur in the
11 Central District of California during the term of this Merit Selection Panel.

12 This General Order shall become effective upon filing by the Clerk of this
13 Court.
